Private Dumpster License

- Required for all Dumpsters kept on private property.
- Complete the appropriate portions of the license application and mail it to the address shown on the front of the application.
- Expires annually on July 31st.

Public Dumpster License

- Required for all Dumpsters that are kept in the public right-of-way.
- Complete the appropriate portions of the license application and mail it to the address shown on the front of the application.
- Expires annually on March 31st.
